

- Forest area: 2 617 628 hectares (37,1 % of the country area)

Green transition

- Green economy = alternative to current economic model with strategical emphasis on improvement of human well-being and building social equity while reducing environmental risks (UNEP, 2024)
- Green economy principles: well-being, justice, planetary boundaries, efficiency + sufficiency, the good-governance (Green Economy Coalition, 2020)
- Green jobs: jobs that help to improve efficiency in energy and raw materials, limit GHG emissions, minimize waste and pollution, protect, and restore ecosystems and supports adaptation to climate change (ILO, 2016)
- *Circular (bioeconomy)*
- *Sustainability*

Methodology

- content analysis applied to documents (forest-based sector direct relevance, national-level, in-force document, public availability of the document) similar to Palátová (2023)
 - Key words: forestry, wood, bioeconomy, circular economy, green economy, carbon
- => Research and Innovation Strategy for Smart Specialisation, National Recovery Plan, National Action Plan for Adaptation to Climate Change
 - *Concept of the State Forestry Policy until 2035 (from 2020)*
 - *Strategy of the Ministry of Agriculture of the Czech Republic with a view to 2030 (from 2016)*
- Project QL24020204 - Impacts of territorial nature protection on the management of forest owners and the wood-processing sector

Territorial protection (1/2) ... current and (future)

- Current - the specific protection of the territory is applied on an area of almost 3 million hectares: 1) large-area (national parks/4 and protected landscape areas/26; 2) small-area (national nature reserves, national natural monuments, nature reserves, nature sanctuaries), and 3) NATURA 2000 system with 41 bird areas and 1112 sites of European importance (AOPK, 2024).
- Forest owner might be compensated for restrictions in specially protected areas (NATURA 2000, commemorative trees, protected plants, animals and minerals; for measures within territorial systems of ecological stability and on the basis of decisions of state nature protection authorities, binding opinions and agreements and is paid from the state budget)/Ministry of Environment + compensations coming from European sources - Ministry of Agriculture does not provide mandated payments related to nature protection, but provides subsidy instruments at the European level (agri-environmental and forest-environmental payments provided under the Common Agricultural Policy and Rural Development Policy).
- Forests (production Forests; protection Forests – e.g., location with unfavourable habitats, mountain forests, windbreaks; special purpose Forests – e.g., suburban, spa, research and education – also where the „other intestest“ is more important than production function/ecosystem services)
- Future protection
 - Chráněná krajinná oblast Soutok/Protected landscape area Soutok
 - Národní park Křivoklátsko/National park Křivoklát (16% of the most valuable area of the current protected national landscape Křivoklát)



Territorial protection (2/2) ... project QL24020204

- Research need of the Ministry of Agriculture of the Czech Republic
- Why is it needed?
 - lacking the impact of restrictions on forest owners in terms of units + financial terms + macroeconomic impacts + impacts on the following sectors (esp. wood-working industry)

Impacts of territorial nature protection on the management of forest owners and the wood-processing sector (QL24020204)

- National-level project funded by the National Agency for Agricultural Research (Ministry of Agriculture)
- Duration: 3/2024-12/2026
- Main investigator: FLD CZU Prague (R. Dudík) – 5 faculty departments involved
- Budget: >10 mio CZK (cca 413 Thous. EUR)
- Project aim to:
 - Differentiate the territorial protection and related restrictions for FO
 - Quantify the impacts of territorial protection of FOs (by volume + in financial terms)
 - Proposal of legislative and conceptual measures
 - Create scenarios for future development of territorial protection in Czechia + evaluation of these scenarios
- Outputs:
 - Methodology – calculation of impacts on FO
 - Legislative changes (administration of the legislation)
 - 3 scientific papers (2 Jimp, 1 Scopus)
 - 3 workshops (including relevant key stakeholders + wood-processing industry)
 - 4 „other“ – communication strategy + project reports

- 2021 – 2026, updated in 2023, Ministry of Industry and Trade (NextGeneration EU)
- *Bioenergy, biomass*
- *Forests resilient to climate change*
- *Water retention*
 - *Nature protection and adaptation to climate change*
(linkage to climate change adapatation strategy – Forest industry, biodiversity and ecosystem services/ES)
 - *Strategic goal 2: ecological stability and provision of ES, prevention soil degradation and increasing natural water regime (game management, forest management regimes, best practices for forest owners, biomass, ...)*

National Action Plan – Climate Change Adaptation Strategy

- 2015 - *Climate change adaptation strategy in the Czech Republic*
- 2017 (2017-2020), 2021 – 1st update for the period until 2025
- Ministry of Environment
- Strategic objective 2: ecological stability and the provision of ecosystem services of forests, with an emphasis on preventing land degradation and strengthening the natural water regime (management practices, game status, gene pool, water retention in the landscape, etc.)
- Cross-cutting measures include payment for ecosystem services, green budgeting, conservation, ecosystem services and awareness raising

Implications for the forest-based sector

- Pressure on joint activities (inter-sectoral cooperation, mutual strategies)
- Alignment of European and national strategies
- „*strong topics*“ coming to the front: e.g., *circularity, bioeconomy, biodiversity, waste management, smart cities, digitalization, AI, ...*
Acceptance or adaptation?
- Monitoring activities needed
- Changes in curricula, changes in demand for (specific) knowledge
- Communication + explanation of forest-related activities needed
- Role of key stakeholders...and forest owners?
- Forest owners
 - Forest management regimes changes (connected to societal demand + perception changes)
 - Less/more tasks and legal issues
 - Financial possibilities (funding and subsidies?)
 - Consequences of payments for ecosystem services
