# AD 1.

Quorum was established (13 of 19 members). Pesident Oblak is leading the Assembly, Candidate Paluš is a member of Assembly presidency, secretary Jelačić is taking minutes. Voting committee is established: Slavica Petrović, Arijana Kruljac, Denis Jelačić.

## **AD 2.**

General Assembly unanimously accepted new members and gave them right to vote and participate in full. New quorum was established (17 of 26).

### AD 3.

Mandate report was given by President Oblak and Secretary Jelačić. Both reports were accepted unanimously.

## <u>AD 4.</u>

Notes of release from duty were unanimously given to President, Executive Board members and Secretary of Association with December 31st 2009.

# AD 5.

According to Association Statute, Candidate for president Huber Paluš automatically becomes new Association President. The 2 years mandate for new president starts on January 1<sup>st</sup> 2010. Huber Paluš was confirmed unanimously.

### <u>AD 6.</u>

Association Secretary Denis Jelačić was given a new mandate for next 2 year by General Assembly unanimously decision.

### AD 7.

Secret election for new Executive Board members took place. Each Association member had a right and possibility to vote for 4 candidates from members list. Candidates with most votes become new Executive Board members. New Executive Board members are: Darko Motik, Leon Oblak, Branko Glavonjić and Richard Vlosky.

# **AD 8.**

On the proposal of new Executive Board, and by General Assembly unanimous decision, Darko Motik was elected for new Association Candidate for president.

### AD 9.

Hosts for next 2 conferences and General Assemblies are Slovakia (for year 2010) and Slovenia (for year 2011).

## AD 10.

Association Secretary gave the proposal for WoodEMA, i.a. to start its own scientific journal which would cover the areas of expertise of its members. Sugestion was accepted unanimously. Also, Code of conduct for journal prepared by Executive Board was accepted unanimously. In rich and fruitfull discussion some tasks were given which have to be fulfilled as soon as possible. Executive Board has to prepare a short letter (as a business plan – on 1 A4 page) as promotion material which should be distributed to all interested parties until November 1<sup>st</sup> 2009. Executive Board should prepare the list of names for Publishing Board of the Journal by the same time. Publishing Board should suggest the Financial plan for Journal until January 1<sup>st</sup> 2010. By the same time, members of Editorial Board, Editor in chierf and Technical Editor should be elected, depending on publishing place. Publishing place should be elected by publishing conditions and prices.

General Assembly lasted for 1 hour and 45 minutes.
